Treasurer Sally Boatman reported on the status of the club's finances. The treasurer's report was approved by the membership after motions by Jack Boatman and Rueben Witt respectively.

Committee Reports:

Day Sailors: No report.

Cruisers: Jim Braun reported that the cruisers are approaching the end of the season and that there was no Frostbite race due to weather.

Youth Sailing: Rob Ritchie reported that 10 new sails were needed for youth sailing. Kevin Gratton shared that the
